2. All transactions with KT Cable Accessories Pty Ltd will be upon the terms and conditions as specified on our website terms and conditions page [www.ktcables.com.au](http://www.ktcables.com.au) as updated from time to time.
3. The title for products and any other goods delivered by KT Cable Accessories Pty Ltd to the applicant shall remain the sole and absolute property of KT Cable Accessories Pty Ltd as legal and equitable owner until such time as all money due to KT Cable Accessories Pty Ltd has been paid to KT Cable Accessories Pty Ltd and shall be at the applicant's risk from the time of dispatch to the applicant. KT Cable Accessories Pty Ltd may for the purpose of examination or recovery of its goods enter upon any premises where they are stored or where they are reasonably thought to be stored.
